## **INTRODUCTION**

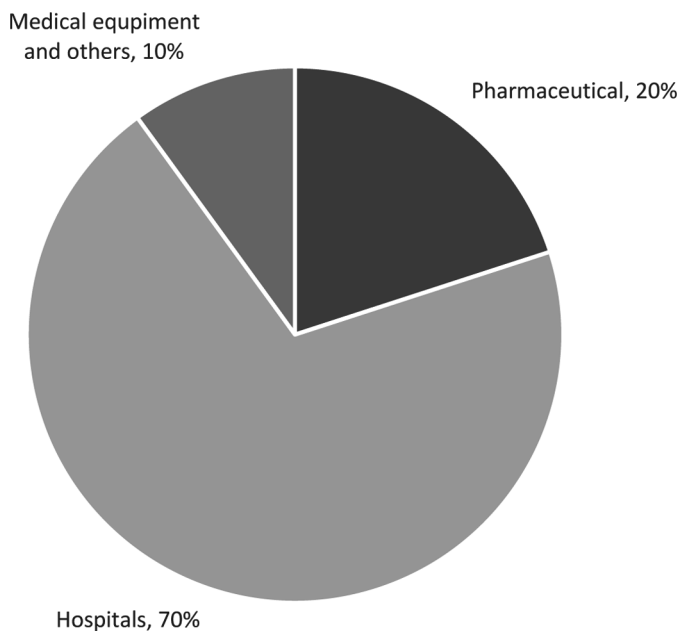
