Law Enforcement's Response to Mass Shootings and Multiple Victim Violence

ABSTRACT

This chapter addresses various methods used by law enforcement to examine mass shootings. It reviews the fact that there is not one consistent definition of mass shootings, and that lacking this definition it makes it a true challenge to identify events that are mass shootings for assessment and analysis. It further discusses the fact that the inability to consistently obtain, assess, analyze, and glean necessary information leading to the understanding of the mindset of mass murders results from the lack of a clear and totally accepted definition of mass shootings. The chapter specifically discusses and examines several methods used by law enforcement in their attempt to prevent and respond to mass shootings. The chapter also provides an understanding that law enforcement must rely on a multiplicity of entities to assist them in trying to prevent and responding to mass shootings to include everyday citizens.

INTRODUCTION

The chapter will address some of the existing ways in which law enforcement is using techniques for prevention, detection, addressing and assessing mass shootings and how the United States Department of Education and Department of Homeland Security have come together regarding mass shootings and have provided sequential steps that should be followed in attempting to address a mass shooting incident.

The chapter will address the issue of what happens when examining mass shootings, and how it truly it becomes obvious that one of the man intentions and focuses of the perpetrator(s) is to create, by their deadly, ruthless and cold but calculating actions, a large number of victims when their actions, senseless to society, but meaningful to them, is complete. There will be a discussion as to the importance of understanding the psychological aspects of a mass shooter and how the media provides them with a blueprint for mentally processing what previous mass shooters have processed and a how to do a mass shooting by publishing every single aspect of a mass shooting from the perspective and actions of the various mass shooters in the past.

The chapter will address the meaning placed upon what appear to be nothing but acts of senseless violence by those not involved or trained and experienced in the area of mass shootings.
