The current study highlights the importance of OER in online learning by reviewing important initiatives, reports, and collaborative arrangements by prominent organizations for promoting the use of OER in online learning as a significant response to COVID-19.*

### INTRODUCTION

The Coronavirus Disease 2019 (COVID-19) at unprecedented growth resulted in substantial mortality and morbidity (Rundle, Park, Herbstman, Kinsey & Wang,

These situations resulted in unmatched issues and challenges ranging from economic instability, unemployment due to Job losses, mental and psychological health, and more severely, its effect on global education at all levels is unprecedented (Nicola et al.,2020). The worst affected educational institutions were those without an online learning platform to address the situation arising due to the pandemic, where online education and distance learning are highly prioritised (Ozili & Arun, 2020).
