# Application of Interpretivism Theoretical Framework on the Management of University Records: Comparison of Selected Universities

### **ABSTRACT**

*This research assessed the adoption of interpretivism paradigm as a theoretical framework. The interpretivism was adopted on a study comparing the University of Venda and the University of Witwatersrand archives and records management programme. This research was undertaken as part of PhD thesis. The study found that adoption of interpretivism paradigm improves credibility, transferability, and authenticity of the research. The research recommend that research in information sciences are to incorporate other paradigm such as positivism.*

### **INTRODUCTION**

Interpretivism's theoretical framework is applied to a qualitative study. This is because the application of the interpretivism paradigm as fundamental affects the choice of the research approach. This case study was conducted to gain an understanding of a particular redesign process of university records management

Matlala (2019), Phiri (2016) applies the interpretivism approach to the management of universities archives and records management. This is an indication that the interpretivism paradigm is a major theory used by information scientists.

There is a need to recognize the participants' viewpoints during the collection of data. The researcher unpacked the significance of the interpretive perspective on the management of university archives and records.

Paradigm shapes the researcher's viewpoints, interpretation, and understand (Babbie, 2017, p. 31). Paradigms are a set of expectations of what constitutes techniques to conduct a study. Research is based on a set of shared assumptions, concepts, values, and practices. Participants' viewpoints were recognized by the author. Paradigms are suitable ways of empathetic reality, building knowledge, and gathering information about the development of the university archive and records management program.

Interpretivism's viewpoint advance its position as a paradigm lies in the fact that is an ontological point of view of reality (Kankam, 2019, p. 850).
